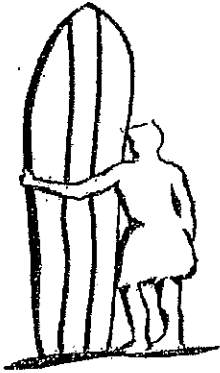
We will have a sixties surf stomp dinner party on Friday night, September 19<sup>th</sup> and this year we'll again have a surprise location.
